What is a 'Data 6ntroller'?

The Data Controller is the body —in this case the Royal Veterinary of Uege (RVC) —that determines the purposes for which and the manner in which an opersonal data are, or after be, processed

What is 'personal dta'?

Under UK Data Protection w "Personal data" means any formation relating to an identified or identifiable living individual. "Identifiable wing individual" means a living individual who can be identified, drectly or indirectly, in particular by reference to (a) an identifier such as a name an identification number, location data or an online identifier, or (b) one or more factors specific to the physical, physiological genetic, mental, economic, cultural or social identity of the idividual.

What is a 'data sibject'?

A 'data subject' is a natural living errson whose personal data is pocessed by a controller or processor. So when we hold and process personal data about our dients they are 'data subjects'

What is Special @tegory Data'?

The law provides a sparate definition for "Special Category Data". This relates to information concerning a data subject's raid or ethnic origin, political opinions, regious beliefs, trade union activities, physical or mental health, exual life, or details for iminal offences. Our legal bases for processing your personal data

Where we are processing your personal data for the purposes of the clinical services we are providing to you we do so on the legal bases antract.

If we are obligated to share your personal data with the police evant bodies such as the RSPCA or the courts then having confirmed that there is a legitimate bases for sharing we will do so on the bases of legal obligation.

Where we use third parties to provide a storage of linical or related services (e.g. microchipping or the providers of our clinical software) we may share limited personal data with them in order to manage the service to you.

Clinical outcomes and reports will be provided to referring Veterinarians.

Animal Welfare concerns

We will normally see permission to disclose your personal data toalles and authorities if we consider that animal welfare or the public interest is compromised. If a client refuses to consent, or seeking consent would be likely to undermine the purpose of the disclosure, the veterinary surgeon along with hospital management will have to decide whether the breach of the data protection act is justified. In these circumstances and where the veterinary surgeon considers that animal welfare or the public interest is compromised, client confidentiality may be breached and appriate information reported to the relevant authorities. Some examples may include situations where an animal shows signs of abuse; where a dangerous dog poses a risk to safety; where child or domestic abuse is suspected; where there is some other significant threat to public health or safety or to the health or safety of an individual; or where the information is likely to help in the prevention, detection or prosecution of a crime.
